## **Applications**

General lubricating and/or freeing off of Cables, Suspension Bushes, Hinges, Door Locks, Brake and Clutch pedals, Sunroof Mechanisms, Bonnet Catches, Bonnet and boot Hinges, Seat Runners, Petrol Caps, Choke and Throttle linkages, Electric Aerials, Steering Column Bushes, Runners on curtain sided trucks, Gear Change Linkages, Gear change Cables and most other areas where a

light lubricant or penetrant is required.

### Instructions

To show the clear nature of this product, spray a small amount onto a steel plate, and point out how it will be less visible in painted areas such as around door hinges and checkstraps.

Agitate with finger to remove the solvent and show to the customer how it changes from a thin penetrant with solvent, to thicker oil like constancy when solvent has dissipated. Explain that this is to allow the product to penetrate before thickening up to provide maximum lubricity.

Encourage the customer to rub the product between finger and thumb to feel lubrication

abilities.
